Project Budget:

1. The total project budget amounts to three hundred fifteen million euros, **315.000.000 €**, excluding VAT. The budget amount is considered as a ceiling bid amount.

Total Unforeseen Costs: **28.350.000 €** (9% of the budget). The amount of unforeseen costs is recalculated at the signing of the Contract on the basis of the Contractor's offered price, with a fixed percentage (9%).

Deadline:

Engineering, procurement, installation, and readiness for testing of the cable system after testing: Duration of thirty-four (34) months, commencing on the date of signature and entry into force of the Contract.

Trial period: Duration of two (2) months, with a deadline of no more than thirty-six (36) months from the date of signature and entry into force of the Contract.

Right to participate in the tender: natural or legal persons and, in case of associations of Financial Entities, their members who are established:

- (a) in a country – member of the European Union (UE), or

- (c) in third countries which have signed and ratified the World Trade Organization (WTO) Government Procurement Agreement (GPA), to the extent that the contract is covered by Annexes 1, 2, 4 and 5 and the General Notes of Appendix 1 of the GPA.
- (c) in third countries not covered by the above but have concluded a bilateral or multilateral agreement with the European Union.

It is clarified that, apart from the above, countries which are in the process of signing a contract under point (c), including observers, as well as countries, which have signed, promotional and reciprocal investment protection agreements or similar financial agreements / contracts with Greece are not excluded.
